News Alert! Painted Hills and Water Policy

TMA has scheduled meetings on behalf of the Community Water Coalition with the Mayor and Council members related to recommendations to amend the adopted water policy. The recommendations were made by the Citizens' Water Advisory Committee (CWAC). We are suggesting some modifications to CWAC's proposals to ensure a solid ongoing water policy. We expect the Council will decide on any changes to the water policy by the middle of March. Of significant concern, however, is that the State legislature is trying to direct the City of Tucson to modify its policy to provide water to Painted Hills. The legislation also would apply to other developments outside the water service area boundary. The legislation, sponsored by Representative David Stevens (District 25--Sierra Vista), was created specifically for the owners of Painted Hills-the Dallas Police and Fire Pension System. If you object to the State of Arizona directing the City to provide water service against its wishes to Painted Hills, please share your concerns with the appropriate State representatives, including:

Currently a review of the water policy is in process, with a number of amendments proposed. It is vital that these amendments <u>not</u> be used to circumvent the new policy. Please make your views known to our elected officials: Please call them, email them, go to council meetings! *Ask them to hold a public hearing on the city's water policy so that all views are heard*.

Council Considers Amendments to Water Policy

When the water policy was adopted by the City Council a little over a year ago, they set up an annual review to ensure the policy works smoothly for the community. The first cycle of this review has been completed by the Citizen's Water Advisory Committee. They identified nine amendments to the water policy and held three public hearings. TMA, and other community groups, attended these sessions and shared their views. Examples of revisions include: 1) defining infill for residential and commercial development,

 2) grandfathering previously approved developments,
3) modifying the Review
Committee's process for approving water service, and 4) changing the guideline of "clear and substantial benefit" for infill to a more narrow definition. Now the Mayor and Council must decide whether to approve these changes. The Community Water Coalition (TMA is a member) is now meeting with the Mayor and Council to share our views, including approval, approval with revision, or do not approve as drafted. We will notify interested members related to the upcoming Study Session and Council meeting on the water policy when these sessions are scheduled in late February and March.

Hillside Development Zone ► Halili Project

You may recall related to the Halili matter, TMA played a role in bringing serious violations of the Hillside Development Zone Ordinance to the attention of the County, and ensuring compliance with our zoning code. In November, Mrs. Halili filed an action for a restraining order, requesting an injunction against two neighbors and the former President of TMA. The Court found no factual basis and no legal justification for the issuance of a restraining

He indicated that the neighbors and TMA have every right to observe activity on the site, and report to the County any zoning issues.

Redistricting in Tucson Mountains

The Independent Redistricting Commission changed the boundaries for Legislative District 3 (for the AZ State legislature). Starting at Star Pass Boulevard and heading north, residents west of Camino de Oeste will be in the new District as well as those residing northwest of Sweetwater Drive and Silverbell Road. The total is about 1.600 residents who will be voting in the new District. It includes Marana, Oro Valley, and portions of Maricopa County. TMA sent its concerns to the IRC and some residents shared their views; but they ultimately decided to leave it as previously proposed.

Hunting Public Hearing Hosted by Parks and Recreation

During the recent hunting season, there were a number of concerns voiced by neighbors related to hunting violations. Hunters were parking along El Camino Del Cerro and going into washes. Additionally, hunters were going onto the Sweetwater Preserve, which has posted signs indicating "No Hunting". As a result, Pima County Natural Resources, Parks and Recreation Department will be hosting a hearing with the hunting community and neighbors living in the area. Guidelines for hunting will be reviewed and discussed. The hearing is scheduled for March 14 at 6:00 to 8:00 p.m. in the Parks and Recreation conference room (3500 West River Road, Tucson, AZ).

F-35 Debate — Public Comment to Begin by Staff

As many of you are already aware, the City of Tucson is still being considered as a training base for the new F-35 Joint Strike Fighter.

Various view points have been expressed on the issue, some in favor and some against. With the release of the draft environmental impact statement, the U.S. Air Force has held public hearings on this issue and we will keep you advised on the TMA website of the outcome.
